- 1 Should the payment order be submitted after the payment order submission time, it shall be effected on the next working day of the Bank.

- 3 The commission fee for incoming transfers in UAH is 0.5% of the transfer's sum.
- $4\,\mbox{The commission}$ fee for intrabank transfers in UAH is 0.2% of the transfer's sum, min. EUR 5.

If the option "Execute only as an instant payment" is marked in the payment order and the recipient bank cannot accept the transfer due to technical or other reasons, the instant payment is rejected and the payment's amount is credited back to the account; this payment is not automatically executed as a SEPA payment.

6 International transfers are payments in EUR where the beneficiary's bank is located outside the Single Euro Payments Area (SEPA).

7 If extra actual costs arise (including any commissions requested by the banks involved in the transfer), the Customer shall pay for them.

8 OUR – commission is covered by the Customer; SHA – commission is shared – AS "Reģionālā investīciju banka" commission is covered by the Customer, the other share is charged from the transfer amount;

BEN – commission is charged from the transfer amount.

9 Possible only upon permission of the bank involved in the transfer.

10 Information on transfers in other currencies is available at the Bank upon request.

⁵ European transfer is a payment in EUR within the Single Euro Payments Area or SEPA, i.e., to recipient banks in the countries of the European Economic Area (EEA) (Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Lichtenstein, Lithuania, Luxemburg, Malta, Netherlands, Norway, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden), as well as SEPA countries outside the EEA (Albania, Andorra, Moldova, Monaco, Montenegro, North Macedonia, San Marino, Serbia, Switzerland, Vatican, United Kingdom), if the respective recipient bank participates in the SEPA system. The payment is executed with the SHA commission fee. It is mandatory to provide the recipient's account number in IBAN format in the payment order. If a transfer with the standard priority cannot be executed as an instant payment (SEPA Instant Credit Transfer), it is automatically executed as a SEPA payment according to the specified submission time.
